The Issues About Doing A Cancellation Of A Dual Nationality Is That Not Everyone Would Be Happy Because In The United Kingdom As In Almost Every Country Of The World There Are People That Resent Persons Like That Because Persons 'who' To Them Were Previously 'Subjugated' Would No Longer Be Subjugated And Would Have Equal Opportunitites Like Themselves And Cannot Be Stopped If They Decide To Aspire To Higher Horizons In Society.

Persons Born In The Same Country Like Themselves Would Now Have The Same Opportunities For Advancement So Therefore Look Out For Jealousies Or Sufficiently Enough Resentment From Some People. If You Had Thought That 'yeah' I Am Now A National From Only One Country, 'My Country' The UK And The Persons Around Me Ought To Be Happy You Would Be In For A Shock As There Are A Lot Of Persons Who Don't Feel That Way, Are Not Patriotic And Would Even Take Donations From Persons Outside Their Own Country To Harm Their Fellow Countrymen And Countrywomen.

You Have Therefore Become A 'Vulnerable Group' And Need To Be Looked After I.E Money From Benefits ,Cheap Housing And Jobs So That You Would Be Easily Adjusted Into The UkAs There Is No Other Country For You To Live In But Your Own Country The United Kingdom. Under The 2014 Immigration And Nationality Act 'Abortion Procedure' A Summary States That Everybody That Has Used A Dual Nationality I.E Two Countries Previously Have To Do An Abortion In A Court Of Law For Them To Come From Only One Country The Uk If It Is Your First Time Of Doing A Cancellation Of A Dual Nationality In A Court Of Law You Are Exempted From Immigration Regulations However You Must Not In Future After You Have Re-Established Your Status As A British Citizen After An Abortion Go To Another Country And Have A Dual Nationality With Another Country In Future Because If You Do That You Would Lose Your Automatic Entitlement To British Citizenship If You Come Back To The Uk And Do An Abortion A Second Time And Want To Be A British Citizen Again What That Means Is That The Uk Would Not Look After

You Again Jobs,Money,Housing Etc And That Your Entitlement To British Citizenship from Then On Would Be That Of A British Citizen By The Power Of Discretion From Immigration And Nationality Or Government Of The Uk. If You Did Not Do An Abortion Previously I.E A Formal Cancellation Of A Dual Nationality With Another Country And You Have Dual Citizenship With Another Country You Would Be A Dual National Even If Your Dual Nationality With Another Country Expires And You Take Up British Citizenship Or You Have Dual Citizenship With Another Country You Still Have Dual Citizenship As Long As You Have Not Done An Abortion In A Court Of Law The Only Time You Would Come From One Country The Uk Is If You Do A Formal Cancellation Of A Dual Nationality In A Court Of Law I.E County Courts Or Magistrate Courts In Areas Where They Don't Have County Courts .It Is Important To Note That You Have To Re-establish Your Status As British Citizens Every Ten Years Since 1971 So If Your Passport Expires Your National Status As British Citizens Would Only Be Renewed Based On The

2014 Immigration And Nationality Act Or Future Immigration And Nationality Laws If The Uk Decides To Update The Immigration And Nationality Laws. Under The New Nationality And Borders Act 2022 If You Have Dual Citizenship With Another Country And You Commit Serious Crimes In The Uk. You Can Be Deprived Of Your British Citizenship If You Travel Away To Another Country And You Are Born Here In The Uk. The Authorities Here Can Persuade The Government Of Another Country To Deprive You Of Your British Citizenship If You Have Dual Citizenship With Another Country.

However Those That Come From Only One Country The Uk Cannot Be Deprived Of Their British Citizenship Under The Nationality And Borders Act 2022.It Is Important To Note That Such Persons Who May Have Dual Citizenship With Another Country Cannot Be Deprived Of Such If They Lived In The Uk Because the Law Does Not Allow It If They Refuse To Come From Another Country And Are British Citizens.

So If You Did Do A Cancellation Of A Dual Nationality Your Uk Birth-Certificate Would Be Prepared For Renewal Purposes That Means That Your Abortion Or Your Cancellation Of Your Dual Nationality Is Successful. This Is Not A Re-Registered Birth Certificate It Was Prepared Like That Because You Had Just Done An 'Abortion' Under The Abortion Act And So That You Would Be Exempted From Immigration Regulations. The Third Paragraph In The Abortion Law States In A Summary That You Have To Re-Establish Your Status After An Abortion For You To Continue As A British Citizen The 'Practical Application'Is That your Uk Documents Are Prepared In Such A Way That You Musnt Be Investigated Or Discussed After An Abortion-Cancellation Of A Dual Nationality In A Court Of Law.

The Reason Being That If You Are Being 'talked' About Or Discussed After An Abortion It Would Affect Your 'Luck' In Life It Would Affect You In Employment, In Relationships And Can Really Be Disturbing .Furthermore Your Red-Birth Certificate Prepared For Renewal Purposes Becomes Your Original Birth-Certificate At Your Local General Registers Office While The Old Red-Birth Certificate Becomes An 'Archive Document' And This Is Kept In The Archives So That In Future If Need Be Reference Can Be Made To It.

The Reason Being That You Cannot Use It Any Longer Because You Have Done An 'Abortion' On A Previous Dual Nationality In Which You Used Your Old Red-Birth Certificate To Have A Dual Nationality With Another Country So Your Old Birth Certificate Becomes Something That You Cannot Use Any Longer And It Would Be A Criminal Offence For You Or Anybody Else To Use It In Future If You Have Been Given A New Birth-Certificate By Your Local General Registers Office This New Birth Certificate Has To Be The Same 100 Level Original Birth Certificate As Your Old Birth Certificate- A Birth Certificate That Somebody From Another Country Or Your Own Country Cannot Own Or Become At Anytime Because It Is For The Person Born Here In The Uk.

Another Thing Also Is That If It Is Your First Time Of Doing A Cancellation Of A Dual Nationality Because The Law Says That You Are Exempted From Immigration Regulations Under The 2014 Immigration And Nationality Act You Can Deny The Other Country You Cancelled Away Throughout Your Life If By Not Doing So You Would Harm Yourself In National Status. Conclusively If At Any Time You Don't Satisfy Them I.E Immigration & Nationality, The Law Says That As Long As You Are Born Here In The United Kingdom They Musn't Refuse You British Citizenship As Long As You Don't Have another Country In Your Name In National Status I.e You Didn't Apply For Another Country's Citizenship Or You Refuse To Come From Another Country That Instead Of You To Be A Stateless Persons That They Must Give You British Citizenship- 2014 Immigration Nationality Act 'Abortion Procedure'.

Furthermore Because You Might Have Been A Dual National Previously Information's About You Would Be In The Country You Cancelled Away Its Dual Nationality Your British Documents Have To Prepared In Such A Way So That The Country You Cancelled Away Its Dual Nationality Would Not Know You Any Longer Because People Or Officials From The Country You Cancelled Away Their Dual Nationality Would Always Have Something To Say They Would Always Have One Grudge Or The Other About Your Assumed Behaviours or Performance When You Lived In Their Country.

So If In Future They Come Anywhere Near Your Country It Is Your Obligation And The Obligation Of Your Country's Officials To Deny That You Are Not The One Who Lived In Their Country. You Have To Re-Establish Your Status After An 'Abortion For Continuity As A British Citizen After One Whole Year Of Doing A Cancellation Of A Dual Nationality.

If Any Serious Problems Arises Since 1956 The United Kingdom Does Not Have An Extradition Treaty With Most Countries Under Its Former Control And So Cannot Help Those Countries That Might Have A 'grudge' At Any Time But Not Every Body Is 'Patriotic' Some Unpatriotic Persons Provide Them Information's Secretly At Any Time However If You Are Confused Or In Doubt Just Deny The Other Country You Cancelled Away Its Relationship Throughout For Your Own Safety.
